Mayor and Council members,

I am commenting to agenda item 8b.

I have worked for some time with our Public Works department to achieve traffic calming on Adams Street. In the past we have discussed a traffic circle and I circulated a petition to install rumble strips. The rumble strips were installed but had to be removed as many motorists chose to drive on the wrong side of the road to avoid them.

After further discussions Glendale PW reached out to LA and then decided they could use the LA regulations for a stop sign in our city. PW chose the intersection of Adams and Scofield as the location for the stop sign because Scofield has sidewalks leading to the intersection which would allow for the installation of crosswalks.

I then walked the area designated by PW and circulated a petition for a stop sign at Scofield. All houses that I spoke to, with the exception of one, were enthusiastic to install a stop sign. They all expressed that traffic on Adams is too fast and several had had hit and run occurrences. The one person who objected to the stop sign said it was because they did not want to lose a parking space on the street as they have 5 cars and could not fit all of them in their driveway.

I'm very happy that this has come before council and urge you to approve this stop sign and make our neighborhood a safer place to live for all the residents.

I am sorry I am not able to attend council in person but I am out of state for a family memorial service.

Please, please approve the stop sign.

Greetings:

My name is Michael Sheehan. I have lived in Adams Hill here in scenic south Glendale since 1986.

From that time to this. over the years, the issue of speeding cars on Adams Street has been an issue.

Shortly after moving here, I was in touch with the then Glendale Traffic Engineer, Wayne Ko, who was civil in his responses to the idea of a stop sign on Adams Street at Cornell Drive.

He, in time, was instrumental in the installation of radar feedback signs on Adams at Cornell and down the hill from Dartmouth on the east side of Adams at the cost of \$9,800.87 each.

The radar signs blink “Slow Down” almost constantly as drivers speed up the hill. Cornell remains a problematic entry to Adams to this day.

Over the years the City of Glendale has made other

unsuccessful attempts to ‘calm’ traffic on Adams at great expense.

Some time ago the City spent time and funds to declare that a roundabout at Scofield and Adams was a solution to ‘calm’ traffic on Adams. Thankfully, the City sent notices in US Post to invite input from neighbors. We showed up and the hue and cry about the loss of parking stalls and essentially, a mess would be the result, stopped that debacle. The City was Transparent. It worked.

Later, the City installed ineffective “calming” standards in the middle of Adams that were destroyed in about two days.

Then, it was reported that Adams Hill Neighborhood Association president. Stephen Meek, had walked up and down Adams Street with a petition to request that the City install ‘rumble strips’ on Adams in an attempt to, again, calm, traffic. Speculation emerged that because of language issues, Some Adams residents may have thought they were supporting ‘bumps’ or ‘humps’ that are used all over Los Angeles to effect. There was no transparency (as with the ineffective standards) for public input or discussion. What was the expense of these ‘rumble strips’ : Installation and removal? .

The noise from cars speeding over the rumble strips and the dangers of impatient drivers swerving into the oncoming lane going up the hill, especially, at all hours of the day and night, causing neighbors even blocks away to be disturbed, required the additional expense of removal. Thank goodness only ugly patches remain.

Literally, hundreds of thousands of tax dollars have been spent for staff research and these failed projects on Adams Street.

Currently, I have learned that the “petition” to vet the idea of an ‘all way stop’ at Scofield and Adams was a very NonTransparent collaboration between The City and Stephen Meek in an attempt to target residents only on the east side of Adams Street and **specifically on Scofield** to essentially ‘re-do’ the failed roundabout debacle.

The Scofield all way stop issue was NOT advertised to inform all of the residents of our entire neighborhood. Why wasn’t this project advertised for locals to weigh in?? Why spend more tax dollars (\$5,000.00 estimated) to create a ‘calming device’ at Scofield that is simply not necessary? What this might do for anyone attempting enter Adams from Cornell... nothing... It will exacerbate the danger, as impatient drivers, heading up Adams Street, having been delayed by the forced Stops at Scofield, to lose energy by stopping and then starting again, certainly at an impatient speed, headed past Cornell up the hill.

Why no well advertised public meeting was called for the Scofield idea is a mystery.

At the Traffic and Parking Commission meeting where only two of the five Traffic and Parking commissioners: Ely Lester and Shana Bonstin, voted to move forward with the Scofield idea, I attempted to make it clear why it was a terrible idea, along with neighbor, Garry Ackerman, as well as a resident of Adams, who did to speak English, but it was very clear that his situation would be severely impacted by the Scofield idea.

After the Traffic and Parking Commission meeting, I learned that Mr. Meek had not circulated the ‘petition’ on his own, but was recruited by the City to do it.

Never was one person west of Adams included in Mr. Meek's petition. Only the east side of Adams was polled. Most specifically on Scofield.

Responding to my experience at the T&P meeting, I sent emails to every single member of the T&P Commission asking for consideration.

Only one commissioner, Mr. Andre Ordubegian, responded and has been involved in attempts to come up with acceptable alternatives to the Scofield re-do of the roundabout.

I contacted Commissioner Ely Lester on Facebook and tried to engage him to discuss why the Scofield idea was a bad one. Mr. Lester responded briefly to me, but has not answered my question if he had ever visited the Scofield site or would meet with Mr. Ackerman and me to discuss alternatives. Shouldn't appointed commissioner be responsive, as Mr. Ordubegian has been? The intersection of Scofield east of Adams is almost a hundred feet wide at Adams Street. To install all way stop signs, several parking stalls will be lost. Stopping will require extra power to mount the hill wasting gas (a complaint from a conservative neighbor that makes sense) and by the time impatient drivers, IF they have stopped, reach Cornell they will be back up to being well in excess of the posted and unrealistic 25 MPH speed limit.

Early on, traffic engineers have said that 'Stops Signs Do Not Calm Traffic' which I resisted, wanting a stop sign on Adams at Cornell. Now, seeing the folly of all that has gone before, I am of the opinion that it is best to leave 'well enough' alone and let the locals find safe passage at Crescent or Dartmouth, and all others take their chances. It is against our impatient human nature to be forced to stop for no apparent reason and

then have to regain momentum to mount a steep incline.

Status quo serves All of Adams Hill. Transparency is vital to a healthy democracy. Sadly, transparency has been lost here.

Mr. Ackerman and I circulated about one hundred letters to all homes west of Adams with an explanation of why a Stop Sign at Cornell was a good idea. That was before we were told that 'regulations' made that impossible. About forty percent return by Self addressed postcards were received back.


Essentially, we have weathered this situation for years and it seems that now, with no ability to get a stop sign at Cornell, we will continue to be cautious and no longer waste tax payer time and our own.

Please dismiss the idea of the Scofield changes.

Dear Mayor Asatryan and Council members Brotman, Gharpetian and Najarian

On behalf of the Adams Hill Neighborhood Association and the signers of an official City Petition, I am advocating for the Scofield/Adams 4-way stop sign to be placed. Adams Hill has advocated long and hard for traffic calming on the South Adams Street leg of the Adams/York Blvd thoroughway that leads to and from Adams Square and the 2 Freeway. We first formally met with the City in November 2021 to make a case for traffic calming.

After years of debate on how to calm traffic Public Works and the neighborhood agreed that a 4-way stop at Scofield and Adams would calm traffic for the Adams Square Mini Park especially relevant to the many children that use the park. The Scofield intersection was agreed after considerable study to be the closest mid-distance cross-street on Adams to our mini park and, therefore, the most practical and safest place to call for cars to come to a dead stop. At 25 MPH, cars will have to slow down to make this stop at least one if not two blocks before they reach Scofield.

The neighborhood was directed by Public Works to circulate a petition on Adams Street to gain community consensus. See Pages 2 and 3. Our AHNA President Stephen Meek and Board Member Mary Baldwin did a lot of work to gather the required signatures and that effort was greatly appreciated. See the attached petition with 76% of the houses agreeing to the stop sign. There were some vacant houses and one objection to the stop sign.

At the Parking and Transportation Commission of July 22, 2024, one objecting resident living at 1255 Adams (with 5 household cars, and a driveway that can accommodate at least 4 cars; photo attached) was allowed to dominate the discussion well beyond the allotted time objecting to the loss of street curb parking for a 5th car. The conduct of the commission was not appropriate in considering this matter. Also, I and other residents have been parking and driving on Adams Street constantly and there is always some empty curb space available. But that is beside the point.

The point is that the Commission's tie decision was not reached in a valid democratic manner. I hope you agree that our collective overwhelming concern for community safety should override the needs of one resident -- even if his extra parking space has to be sacrificed to a red curb.






