This issue has become very politicized, with the citywide bike transportation plan generating a lot of hysterical negative responses, along with some legitimate concerns. But I am struck by how much neighborhood support there has been for this project from those who live adjacent to La Crescenta and south of Honolulu. Residents are concerned for their children's safety.

I have travelled this route by car probably a thousand times since I've lived in Glendale. Cars need to be slowed down. It is not a traffic pinch point. I can't think of a street in our city better suited for the proposed changes.

Due to a schedule conflict, I am unfortunately not able to attend and speak in person, so I wanted to share my story with you in the hopes that it will show you the importance of changing the road.

Two years ago, our family (with 7 children) made a commitment to be as carbon free as possible as a family. We made big changes at that time. One of them was that we bought an ebike with the ability to fit 2 children on the back. With a baby bike trailer on the back, it gave me the ability to bike around with 4 children in tow. I bike on La Crescenta Ave with my children every day. Biking is the way that I get my 3 children at Fremont Elementary school to and from school every day. Sometimes, our neighbors join us too and we have a large bike bus that uses La Crescenta Ave. It is also the way that I get to the grocery store, soccer practice, and any other activities for our family. I also have a son who is a junior at CV High School who uses his ebike on La Crescenta Ave to get to and from his activities every day.

Currently, this is not safe for us. We have 2 current options.

First, we can use the sidewalk. There are many driveways and intersections where cars pull out. These drivers are distracted by the traffic and do not look for us on the sidewalks. This has resulted in my older son being hit by a car and many other very close calls. The sidewalk is too narrow in spots for my bike trailer, so it results in my children trying to bike on the sidewalk while I use the road at times. The sidewalk is also uneven. This resulted in my neighbor's son being thrown from his bike and breaking his nose.

The second option is to ride in the road. This means my small children (my 7 year old has ridden her own bike since kindergarten) ride their bikes with vehicle traffic. Drivers do not always give us the space they should. They sometimes stay so close that I can reach out my foot and tap on their vehicle! It also means we have to stop on the shoulder of the road and try and wait for traffic to clear so that we can cross the road to the school. The shoulder is about 3 feet wide.

As you can see, neither of these options are safe for our family.

Please vote YES on item 8A at the city council meeting today, Tuesday, August 27th. Help make La Crescenta safer for my family and other families like us.
