Summary of Model Programs

1) **San Francisco Commission on the Status of Women**

The San Francisco Commission on the Status of Women (COSW) is dedicated to ensuring equal opportunities for women and girls across economic, social, political, and educational domains in the city. Established in 1975, the Commission operates through the Department on the Status of Women (DOSW), created by voter-approved Proposition E in 1994. [SFCSW](#)

Key Programs and Initiatives:

1. **Health & Safety:** The Commission addresses various aspects of women's health and safety, including domestic violence, sexual assault, and human trafficking. Programs are tailored to meet the needs of diverse communities in San Francisco, such as Arab, African American, Asian, Latina, and transgender populations. [ohchr.org](#)
2. **Economic Security:** Recognizing the importance of financial empowerment, the Commission offers services that support financial stability and mobility. These services encompass job and employment support, housing assistance, financial literacy programs, subsidized childcare, paid family and dependent leave, savings and investment guidance, and entrepreneurship opportunities. 3. **Civic Engagement & Political Empowerment:** To promote active participation in governance, the Commission provides trainings, educational workshops, and public service campaigns. These initiatives aim to organize, educate, and encourage women, girls, and nonbinary individuals to engage in all levels of government, ensuring their voices are heard in the political arena. As of the latest available data, the San Francisco Department on the Status of Women operates with an annual budget of approximately \$6 million. Notably, about 90% of this budget is allocated to community-based organizations that provide essential services to women survivors of domestic violence, sexual assault, and human trafficking.
