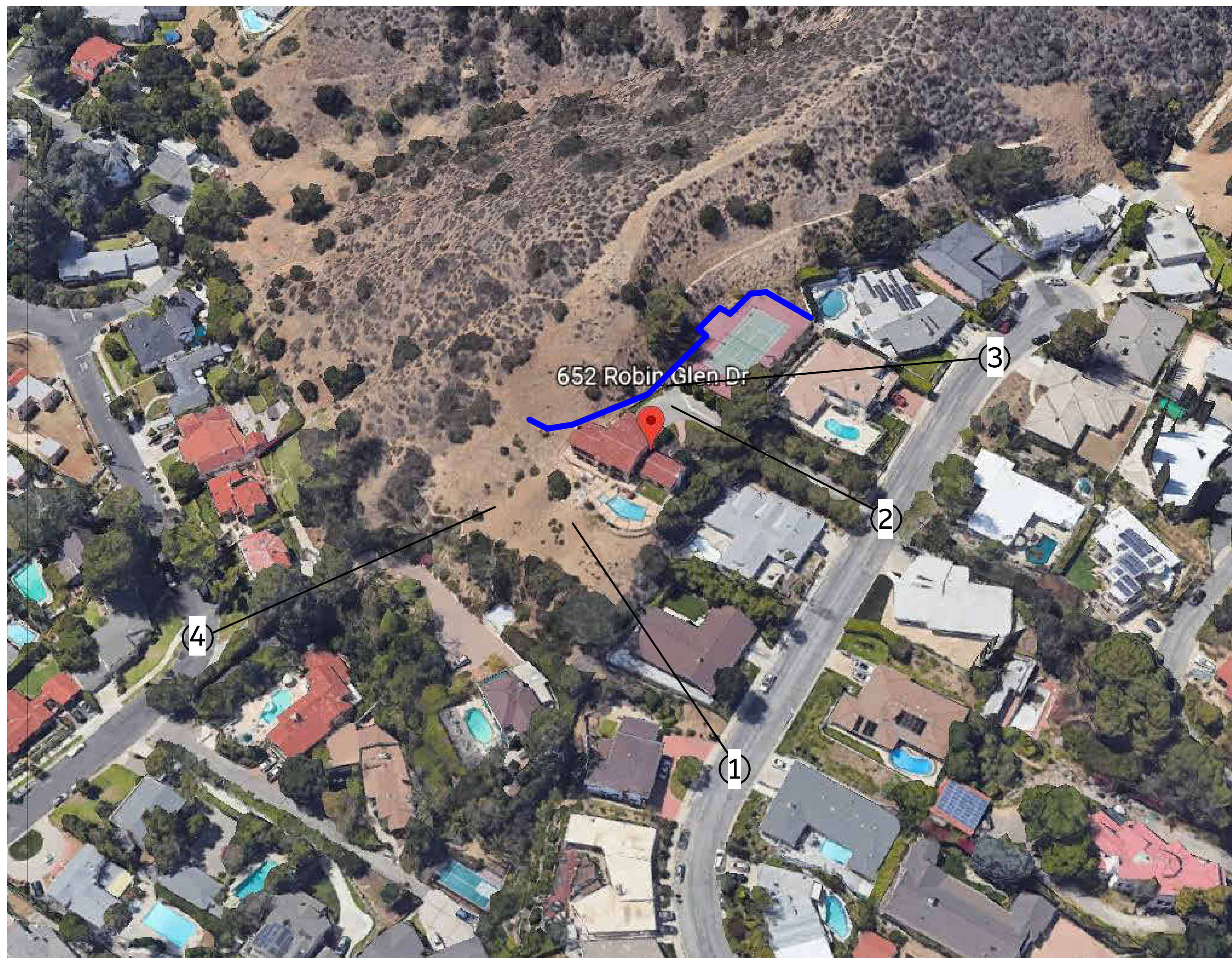


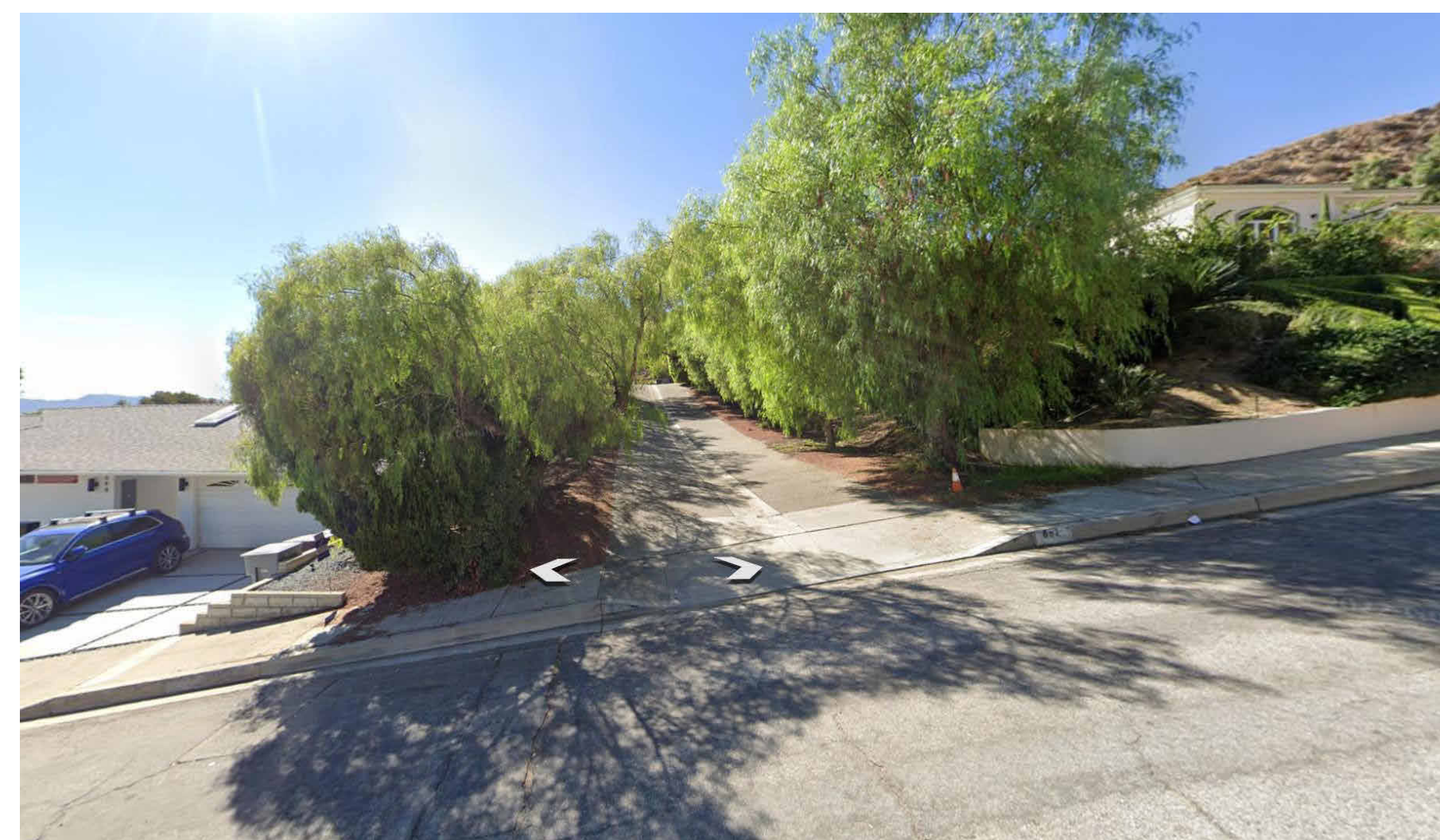

THE WALL IS UNDER 15 FEET.



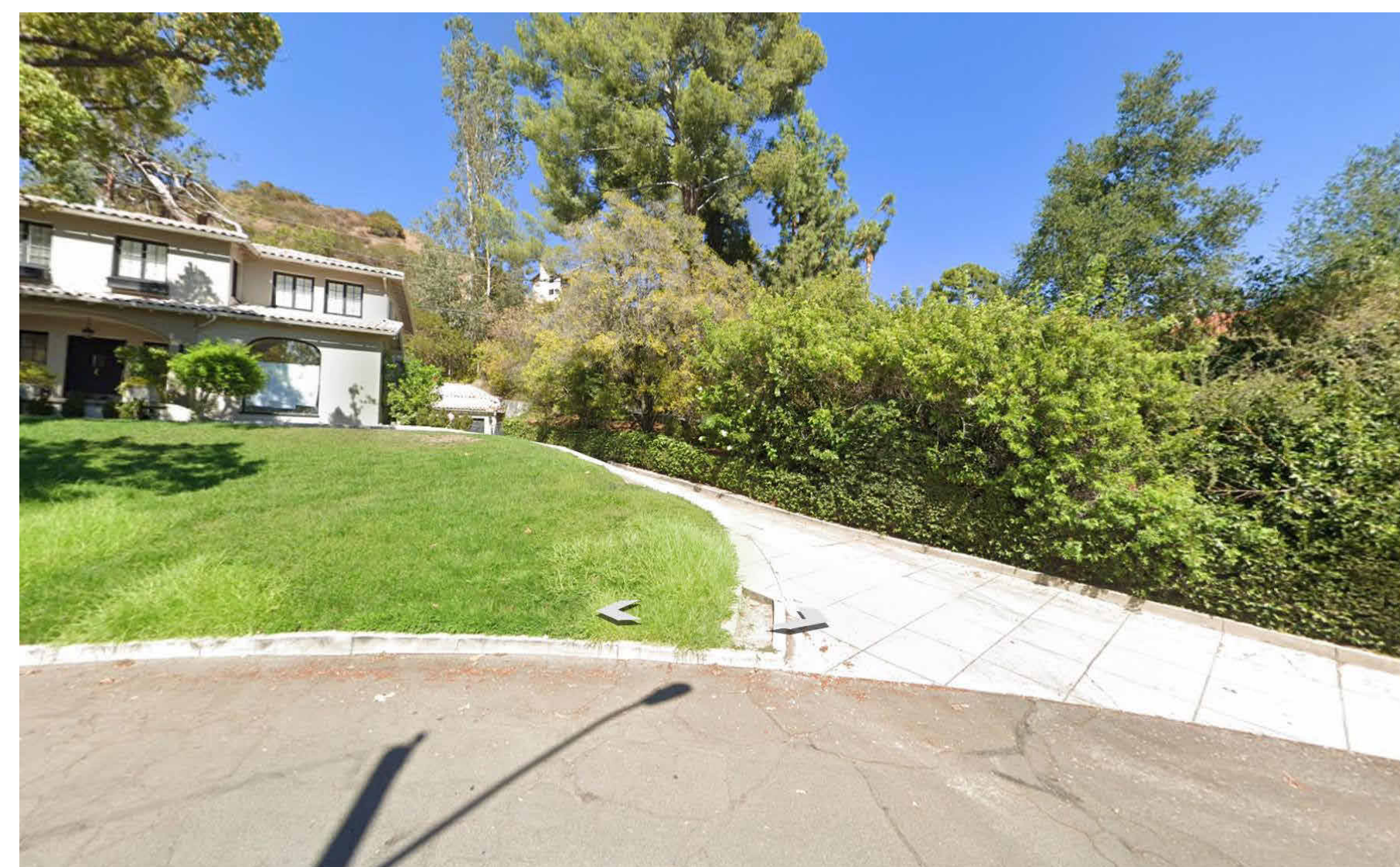
