Dear Council Members & Staff,

As you are aware, the Crescenta Valley Community Association has been following Rockhaven history for some time and supporting the efforts of Friends of Rockhaven. In the past, we have criticized the RFP process, the number of unsuccessful building partners, and the intent to build affordable housing on the site. We have also expressed our concerns regarding obvious neglect of the buildings and lack of progress in preserving the historically significant property.

Therefore, we were delighted when the City voted to move forward with the project as outlined by the State funded grant. However, we are surprised that the current design as planned does not include accessible outdoor restroom facilities to serve the public park. Instead, the design changes the original footprint of the Pines Cottage to accommodate one additional bathroom and alter the others. This plan is a departure from the original intent of the museum space.

State Senator Anthony Portantino secured \$8 million to build a museum AND park and it is imperative that Glendale work toward this end. The CVCA would like to respectfully request that Council direct staff to leave the inside of the Pines Cottage in its original state, to the extent possible, and shift funds to build fully accessible

restrooms outdoors. This will take us one step closer to creating the museum and park for the community who has been waiting for so long.

To the Glendale City Council 2025,

For 18 years the City of Glendale has had the opportunity to do something remarkable with the unique historic gem within its care.

For 12 years the Friends of Rockhaven have asked for the most amount of preservation and the least amount of change.

In the last year THIS council – you five – have had the honor of being able to create plans to preserve and interpret the original spaces and history at Rockhaven Sanitarium.

In the last months we have pleaded with you to not allow the plans that permanently alter the interiors of the Pines Cottage.

We knew the rest would have to change. We knew there would be irreversible changes to make the grounds accessible and the buildings into businesses. So, we asked for one. One building only to remain as original as possible. We chose the building with unique architectural details and vibrant tiles so that it could be seen the way it was when women were cared for there, the rooms full of displays dedicated to medical, mental and women's history.

I regret that choice. It is resulting in the demise of exactly what we hoped to preserve. Because you have chosen a plan that takes away 4 of the 9 rooms. You had the power to alter these plans to save this space! But you turned a deaf ear and remained dumb instead of speaking up.

You had one opportunity to have a remarkable legacy of preservation at a most unique spot in history. You. But you chose to let it vanish forever.

I was warned about this years ago. I was told that everything would have to be taken up and redone because, "that's the way we do it in Glendale." What a fool I was for thinking this could be different. That we would seize this opportunity. That THIS council would be better.

I should have known.

I would like to remind you what the community wants for Rockhaven and how the new plan being considered tonight deviates from that vision. Back in 2010, Glendale put out the video, Rockhaven: A Sanctuary From Glendale's Past <https://www.youtube.com/watch?v=88-u9JENth0> that outlined how important it is to preserve Rockhaven. In the words of Glendale staff and local historians, the focus was preservation for community use.

While the community appreciates that Glendale is finally moving forward on the long-awaited project, we are very concerned by the amount of change scheduled for the Pines Cottage. The voice of the community has always been, "the most amount of preservation with the least amount of change." The substantial changes to the interior of the cottage will remove the original charm and history which would be a significant loss.

We have suggested an alternative compromise which would ensure the building is restored to its former beauty and safety but not gutting the interior. We suggest a light hand when making the current bathrooms in the Pines Cottage usable and constructing new bathrooms outdoors in the park space that is accessible to those with disabilities. Additionally, we request that no walls be moved, or interiors be substantially altered to keep the maximum amount of history preserved.

Please give this commonsense idea your fullest consideration.
