A RESOLUTION OF THE COUNCIL OF THE CITY OF GLENDALE, CALIFORNIA AUTHORIZING THE CITY MANAGEMENT, OR A DESIGNEE TO EXECUTE AN AMENDMENT TO THE AGREEMENT FOR BUSINESS AND MULTI-FAMILY SOLID WASTE COLLECTION SERVICE IN ZONE A BETWEEN THE CITY OF GLENDALE AND SOUTHLAND DISPOSAL COMPANY (CONTRACT R107070) ASSIGNING THE AGREEMENT TO SOUTHLAND ENVIRONMENTAL SERVICES INC.

WHEREAS, Section 8.56.170 of the Glendale Municipal Code, authorizes exclusive collection for solid waste collection services for business and multi-family properties through an exclusive franchise agreement authorizing and obligating the holder to provide collection services within a franchise zone. by resolution of the Council of the City of Glendale; and

WHEREAS, the franchise agreement provides that the consent to any assignment is in the sole discretion of the City Manager, as approved by Resolution adopted by the City Council; and

WHEREAS, the franchise agreement provides that any application for a transfer of rights must include a transfer fee in the amount of \$50,000; and

WHEREAS, on April 8, 2024 and July 9, 2024, Robert Arsenian, owner of Southland Disposal Company and Southland Environmental Services, Inc., made a formal request for assignment and a request to lower the contractual assignment fee from \$50,000 based on Mr. Arsenian's representation that he was the sole owner of both entities and that there as no intention to sell or transfer any assets; and

WHEREAS, based on the nature of the requested assignment resulting in only a name change of the current operating company, reduction of the fee from \$50,000 to \$15,000 is acceptable;

WHEREAS, the City Manager approves the request for assignment and recommends approval of the motion authorizing this change.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLENDALE, CALIFORNIA:

SECTION 1. Approves the assignment of the Agreement for Business And Multi-Family Solid Waste Collection Service In Zone A Between The City Of Glendale And Southland Disposal Company (Contract R107070) from Southland Disposal Company to Southland Environmental Services, Inc.

SECTION 2. The transfer fee of fifteen thousand dollars (\$15,000.00). shall be paid by Southland Disposal Company or Southland Environmental Services, Inc.

SECTION 3: This Resolution shall have no force or effect unless and until a) the transfer fee in an amount equal to fifteen thousand dollars, \$15,000.000 is paid and received by the City of Glendale from Southland Environmental Services, Inc.
