### **EXECUTIVE SUMMARY**

---

Councilmember Kassakhian requested, and the Council directed staff to prepare a resolution condemning the ethnic cleansing and genocide of Armenians in Artsakh be placed on the agenda for discussion by the full Council. On January 30, 2024, the Council directed staff to bring forward this resolution holding the Azerbaijani government leaders accountable for genocide.

## **RECOMMENDATION**

---

Adopt the resolution affirming Glendale's commitment to human rights and international justice.

## **ANALYSIS**

---

On January 23, 2024, Councilmember Kassakhian requested a resolution condemning the ethnic cleansing and genocide of Armenians in Artsakh be placed on the agenda for discussion by the full Council. On January 30, 2024, the Council directed staff to bring forward a resolution.

Artsakh, formerly Nagorno Karabakh, is the ancestral homeland of Armenians, maintaining autonomy until 1921 when Joseph Stalin arbitrarily separated it from Armenia, placing it under Soviet Azerbaijan's control. In response to escalating anti-Armenian violence, Artsakh declared independence on September 2, 1991, leading to a war of aggression by Azerbaijan, human rights violations, and a Russian-brokered ceasefire. Over the next 25 years, Artsakh developed into a free and democratic society.

In September 2020, Azerbaijan launched a war, resulting in ethnic cleansing and documented human rights abuses. Despite a trilateral ceasefire in November 2020, Azerbaijan continued aggression, including a total blockade in December 2022, leaving 120,000 Armenians facing critical shortages. In September 2023, Azerbaijan's militarily overwhelmed Artsakh, committing genocide and cleansing the region of Armenians.

Glendale, home to the largest Armenian American population in the US, has actively raised awareness about the plight of its indigenous Armenian population amidst Azerbaijan's relentless aggression. The U.S. acknowledged Azerbaijan's threat in 1992 with Section 907 of the Freedom Support Act in 1992, prohibiting assistance until blockades cease. The resolution finds Azerbaijan's leaders responsible for genocide, urging the U.S. to act under the Genocide Convention.

This Resolution emphasizes Glendale's commitment to addressing Azerbaijan's human rights violations and calls for U.S. action to prevent and punish the genocide preparators.
