### EXECUTIVE SUMMARY

---

The historical cast iron street light standards in the Rossmoyne Neighborhood and Honolulu Road Area are rusted and require a fresh coat of paint. The size and volume of this project and lack of both trained field personnel and adequate equipment, necessitate the temporary hiring of a contractor to perform the needed painting of street light poles.

### RECOMMENDATION

---

Approve a Resolution to adopt Specification for Painting Street Light Standards in the Rossmoyne Neighborhood and Honolulu Road Area for Glendale Water and Power, and direct the City Clerk to advertise for bids.

### ANALYSIS

---

GWP continues to strive to provide efficient, reliable street lighting systems that enhance the character of our communities. The street light poles in the Rossmoyne Neighborhood and Honolulu Road Area are rusted and require a fresh coat of paint. Painting these poles not only protects City's infrastructure but it also beautifies the neighborhoods and improves the city aesthetically. GWP has prepared Specification No. 3995 to address the painting of the streetlights in the Rossmoyne Neighborhood and Honolulu Road Area. Pursuant to Specification No. 3995 and the contract to be awarded, a total of 226 single globe and double globe street light standards will be painted. Staff estimates this project to take less than six months to complete.
