Comprehensive Operational Analysis & Integration Study (COA) Project



- Last conducted a transit route analysis in 2018-2019
- Pandemic affected transit systems worldwide including Beeline.
- Will help provide a complete vision of how Beeline can adapt to the changes and reorient service.
- COA results are expected to provide a framework for effective Beeline service deployment within available financial and capital resources.
- COA is a year-long project.



COA Key Activities

- Requires selected firm to perform the following:

1. Create and implement an in-depth public outreach program to engage riders and non-riders.

2. Understand existing fixed route usage on Beeline, Metro, BurbankBus, and LCF shuttle in Beeline service area.

3. Develop a plan that reimagines transit service deployment in the Beeline service area and develops recommendations for coordinated routes between Beeline and other transit providers.



RFP Process

- Issued RFP
- Received two proposals
 - Dan Boyle & Associates LLC (DBA)
 - Transportation Management & Design, Inc. (TMD)
- Reviewed proposals and interviewed firms
- Evaluated and scored proposals based on evaluation criteria
 - Evaluators included Glendale's Transit Manager, and transit professionals from LA Metro and City of Torrance (Torrance Transit)
- Individual scores averaged to provide final ranking



Proposal Evaluation

- DBA Proposal
 - Highest score and lowest cost.
 - Well tailored to the scope of work.
 - Brings a fresher perspective by teaming with Jarrett Walker + Associates.
 - Assembled team has an outstanding understanding of Glendale service area, demonstrated subject matter expertise, and demonstrated commitment to Beeline's continued success.

COA Project Cost



- During negotiations, staff requested additional services to enhance the study
 - Some requested services are additions while others may be optional depending on various outcomes
 - More outreach efforts
 - A fare study
 - Revision of our most recent civil rights Title VI report
 - Development of collateral materials
 - A post-implementation evaluation
- Total not-to-exceed project cost is \$392,139
 - \$67,000 more than DBA's initial proposal but still lower than TMD's proposal



Recommendation

- Approve the contract award to DBA for the Comprehensive Operational Analysis and Integration Study project.
- Adopt the Resolution of Appropriation for \$150,000 for the integration study.
