July 8, 2024, at 5:30 PM**

**1. ROLL CALL – 5:30 PM**

- The meeting was called to order on, July 8, 2024, at 5:30 PM.  
*Present:* Commissioner Bartosouf, Commissioner Werner, Commissioner Pinkerton, Vicechair Kartounian, Chairperson Bazemore, and Ex-Officio Welch.

**2. APPROVAL OF MINUTES**

a) **Approval of the Minutes of the Commission special meeting held on June 17, 2024.**

**3. BOARD MEMBER/STAFF COMMENTS ORAL COMMUNICATIONS**

*Commissioner Comments:*

- Vice Chairperson Bazemore presents the Environmental Stewardship Award to Student Ex-Officio Welsh and Ex-Officio Ispendjian in recognition of their service to the Sustainability Commission.
- Commissioner Bartrosouf, Werner, Kartounian, and Pinkerton thank the Ex-Officio members for their service.
- Chairperson Bazemore inquires who the point of contact is heatwave response at the City. Mr. David Jones clarifies that the City does not have a specific Heat Resilience Officer, but Community Services and Parks coordinate and manager the cooling centers that citizens can access.
- Commissioner Pinkerton inquires if the City has ever identified properties, especially multi-family properties, that do or do not have air conditioning. Commissioner Pinkerton also suggests that the City reviews codes and ordinances considering increased heat events to determine if the City's buildings are adequately prepared.
- Chairperson Bazemore moves to make this topic an item at a future commission meeting.
- Commissioner Werner seconds that as an agenda item.

#### **4. ORAL COMMUNICATIONS**

#### **5. ACTION ITEMS**

##### **a) Selection of Student Ex Officio non-voting members**

1. Motion approving the selection and appointment of Student Ex Officio non-voting members to the Sustainability Commission.

#### **6. REPORTS/INFORMATION**

##### **a) Environmental Preferable Purchasing**

- Mr. Jones gives an overview of environmentally preferable purchasing and details of products that the City of Glendale utilizes.
- Commissioner Pinkerton suggests utilizing rechargeable batteries with

chargers for employees at the City.

- Commissioner Pinkerton suggests using chlorine and bleach free janitorial paper. She also suggests an outreach campaign “Lose The Lawn” to cut down on the organic waste that the City must process.
- Commissioner Bartrosouf suggests a policy that discourages the City of Glendale from using gas generators at events. The Commissioner also suggests repurposing fallen trees instead of shredding them into mulch. In addition, Commissioner Bartrosouf suggests investigating the use of more natural materials.
- Vicechair Kartounian recommends implementing an inter-city swapping program. The Commissioner also recommends that the repurposing program has three tiers, one for internal City workers, one for nonprofits, and one for the public.
- Chair Bazemore inquires if the public works department is investigating low emission concrete technology.

## **7. SUSTAINABILITY OFFICE UPDATES**

### **a) Event Update**

- Staff member provides updates on events such as Clothing Swap, Repair Café, Earth Month Programming, and Climate Cafés.
- Staff member provides data on the number of participants, locations, successful repairs conducted by volunteers, and items swapped.
- Commissioner Bartrosouf suggests incorporating e-waste services for appliances and batteries as part of Repair Café.
