**A RESOLUTION OF THE COUNCIL OF THE CITY OF GLENDALE,  
CALIFORNIA, DISPENSING WITH COMPETITIVE BIDDING AND  
APPROVING AN AGREEMENT WITH CALNET**

**WHEREAS**, the Information Technology Department is responsible for overseeing the City's telecommunications services, ensuring optimal service and cost-efficiency and since 2010, the City has leveraged the CALNET program, administered by the California Department of Technology, for competitively bid telecommunications contracts;

**WHEREAS**, this strategic approach eliminates minimum purchase requirements, affording the City flexibility and control over future spending, which are contingent upon the City's budget allocations and approval processes, thereby ensuring fiscal responsibility and alignment with the City's evolving needs and priorities;

**WHEREAS**, the IT Department will continue to monitor industry trends and available options to guarantee that the City's telecommunications infrastructure remains efficient, reliable, and cost-effective;

**WHEREAS**, Glendale Charter Art. VI, Sec. 9 provides an exemption to competitive bidding for, among other things, contracts with other governmental entities, or their contractors, for labor, materials, supplies or services.

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF  
GLENDALE:**

1. That the foregoing facts are deemed to be true and correct and a basis for dispensing with competitive bidding and authorizing the execution of an agreement with a single source.

2. That pursuant to Glendale Charter Art. VI, Sec. 9 provides that competitive

bidding shall not be required for contracts with other governmental entities, or their contractors, for labor, materials, supplies or services.

3. That, the City manager is hereby authorized to execute an agreement with CALNET for the provision of all telecommunication services which are available, and an option to renew upon approval of the City Manager.

4. That no new appropriation is being requested at this time; however, all services ordered and provided under the CALNET contracts are subject to the appropriation limits approved by Council as part of the annual budget process.
