**IV. Other Business and Announcements**

- A. Steve Kaplan shared that in the late evening hours of Sunday, September 24, 2023, the Alliance of Motion Picture and Television and Writers Guild of America (WGA) reached a tentative agreement after an approximate 170-day writer's strike protesting contract negotiations. The terms have not been released yet; however, relative posts on social media have indicated that this agreement is one of the most significant and substantial agreements drafted since the last writer's strike, which took place in 2008. Some of the concerns that were brought to light with this strike were that of a financial nature due to recent cutbacks of writers' rooms and the fear of these jobs being replaced by Artificial Intelligence (AI) Technology utilized by the industry. During the Sunday evening negotiations, there were apparently very significant gains achieved in almost all aspects of the terms that were being negotiated.
