**A RESOLUTION OF THE COUNCIL OF THE CITY OF GLENDALE, CALIFORNIA,
APPROVING THE RESPONSE TO THE 2019-2020 LOS ANGELES COUNTY CIVIL
GRAND JURY FINAL REPORT ON DETENTION, AUTHORIZING THE MAYOR TO
EXECUTE, AND DIRECTING THE INTERIM CITY MANAGER, OR HIS DESIGNEE, TO
TRANSMIT SAID RESPONSE TO THE PRESIDING JUDGE OF THE LOS ANGELES
COUNTY SUPERIOR COURT**

WHEREAS, California Penal Code section 919(b) provides: “The grand jury shall inquire into the condition and management of the public prisons within the county[.]”;

WHEREAS, during the months of August, September, and October of 2019, the 2019-2020 Los Angeles County Civil Grand Jury performed unannounced inspections of detention facilities in the county including the jail at the Glendale Police Department;

WHEREAS, on or about July 31, 2020, the Los Angeles County Civil Grand Jury released to the public its report entitled “Detention” in its 2019-2020 Los Angeles County Civil Grand Jury Final Report and said report contains recommendations;

WHEREAS, California Penal Code sections 933(c) and 933.05 require a public agency to provide a written response to recommendations contained in a final report of the Los Angeles County Civil Grand Jury;

WHEREAS, staff has reviewed the Detention Report contained in the 2019-2020 Los Angeles County Civil Grand Jury’s Final Report and has prepared a proposed response to the recommendations contained therein; and

WHEREAS, the City Council has reviewed and considered the proposed response, as set forth in the report by the Chief of Police to the City Council dated October 27, 2020, and attached thereto as Exhibit 3.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GLENDALE,
CALIFORNIA DOES RESOLVE AS FOLLOWS:**

SECTION 1. The proposed response, attached as Exhibit 3 to the report by the

Chief of Police to the City Council dated October 27, 2020, to the recommendations contained in the "Detention" report is hereby approved as the City of Glendale's official response.

SECTION 2. The City Council does hereby authorize the Mayor to execute, as substantially attached, and for the Interim City Manager, or his designee, to transmit said response, for and on behalf of the City of Glendale to the Presiding Judge of the Los Angeles County Superior Court.
