**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
GLENDALE, CALIFORNIA, TO DESIGNATE NIBLEY PARK
(GR-135) LOCATED AT 1103 E. MOUNTAIN STREET, AS A
HISTORIC RESOURCE ON THE GLENDALE REGISTER OF
HISTORIC RESOURCES**

WHEREAS, the owner of record of the Nibley Park, located at 1103 E. Mountain Street, has consented to, and requests that Nibley Park be designated as a historic resource on the Glendale Register of Historic Resources pursuant to the provisions of Section 15.20.060 of the Glendale Municipal Code; and

WHEREAS, the Historic Preservation Commission, at a regularly scheduled meeting, on August 20, 2020, unanimously recommended designation of Nibley Park for listing on the Glendale Register of Historic Resources; and

WHEREAS, the City Council has conducted a duly noticed public hearing pursuant to the provisions of Section 15.20.060 of the Glendale Municipal Code; and

WHEREAS, the City Council of the City of Glendale, pursuant to Sections 15.20.050 and 15.20.060, finds based on information in the record that Nibley Park, located at 1103 E. Mountain Street, is eligible for listing on the Glendale Register of Historic Resources because it qualifies under Criteria 1 (identified with important events in national, state, or city history, or exemplify significant contributions to the broad cultural, political, economic, social, tribal, or historic heritage of the nation, state, or city, and retain historic integrity) and 2 (associated with a person, persons, or groups who significantly contributed to the history of the nation, state, region, or city, and retains historic integrity) in that Nibley Park retains strong associations with its initial development as an open, somewhat natural, space devoted to public enjoyment, is strongly associated with the Rossmoyne subdivision (one of the most important components of the city's early developmental heritage and recognized today as a designated historic district), and although altered over the years, retains its character as a public space intended for the recreational use of city residents, thereby maintaining its connection to an original aspect of this neighborhood's development; and is closely associated with C.W. and, especially, Alex Nibley, who led the subdivision and development of the Rossmoyne neighborhood and became an important figure in Glendale's historical early residential development.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLENDALE AS FOLLOWS:

Section 1. The recitals above are incorporated herein by this reference.

Section 2. That Nibley Park is to be designated as a historic resources in the Glendale Register of Historic Resources.

Section 3. That the designation of Nibley Park as a Historic Resource for listing on the Glendale Register of Historic Resources is exempt from further review under the provisions of the California Environmental Quality Act (CEQA) pursuant to Title 14 CCR, Sections 15308 (preservation of the environment) and 15331 (preservation of historic resources).
