**RESOLUTION OF THE COUNCIL OF THE CITY OF GLENDALE, CALIFORNIA
AUTHORIZING THE INTERIM CITY MANAGER OR A DESIGNEE TO EXECUTE ALL
NECESSARY DOCUMENTS ASSOCIATED WITH THE UNITED STATES
DEPARTMENT OF HOMELAND SECURITY, 2019 STATE HOMELAND SECURITY
GRANT PROGRAM**

WHEREAS, the City of Glendale has been successful in obtaining \$426,900 under the United States Department of Homeland Security, 2019 State Homeland Security Grant Program;

WHEREAS, these grant funds are allocated between Los Angeles County and those cities recognized by the County of Los Angeles Operational Area which includes the City of Glendale;

WHEREAS, the grant is administered by Los Angeles County and the funds are available for purchases of approved equipment, supplies, and for the training of first responders that meet identified national, state, county, and local priorities;

WHEREAS, the projects associated with the State Homeland Security Grant Program are for the purposes of continuing efforts to strengthen capabilities and enhance public safety and preparedness efforts within the City of Glendale and the region;

WHEREAS, the agreement associated with the grant authorizes funds for equipment, training, and maintenance for the City's Fire and Information Services Departments, as more specifically discussed in the report to the City Council dated March 2, 2021 by the Fire Chief and the Chief Information Officer;

WHEREAS, the projects under the grant have been approved by the State of California Office of Emergency Services Homeland Security branch;

WHEREAS, the grant is a reimbursement grant and requires no matching funds;

WHEREAS, any liability arising out of the performance of the agreement related to this grant shall be the responsibility of the City of Glendale;

WHEREAS, grant funds shall not be used to supplant expenditures controlled by the City Council; and

WHEREAS, the City Council authorizes the Interim City Manager to execute the agreement, certifications, and associated documents for the 2019 State Homeland Security Grant Program.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLENDALE, CALIFORNIA AS FOLLOWS:

The City Council hereby:

SECTION 1. Approves participation in the 2019 State Homeland Security Grant Program and accepts the grant funds under this program in the amount of \$426,900.

SECTION 2. Authorizes the Interim City Manager, or a designee, to execute all necessary agreements, certifications, and documents to accept and implement the grant.
