A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GLENDALE APPROVING THE ENGINEER'S REPORT FOR THE CITY OF GLENDALE'S NORTH SAN FERNANDO ROAD CORRIDOR LANDSCAPE MAINTENANCE DISTRICT FOR FISCAL YEAR 2021/2022

WHEREAS, this City Council has examined and reviewed the Engineer's Report as presented, and hereby finds that the assessments and charges have been spread proportionately in accordance with the special benefit each property receives from the improvements, operation, maintenance and services to be performed, as set forth in said Engineer's Report or as modified by Council action and incorporated herein.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GLENDALE DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The above recitals are true and correct.

SECTION 2. The Engineer's Report as presented is hereby approved pursuant to *Section 22623* of the Act and provisions of the Municipal Code, and ordered to be filed in the Office of the City Clerk as a permanent record and to remain open to public inspection.

<u>SECTION 3.</u> Copies of this resolution shall be filed in the offices of the City Manager, Finance Director and Public Works Engineering Departments.

<u>SECTION 4.</u> The Mayor shall sign and the City Clerk shall attest to the adoption of this resolution.
