**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GLENDALE,  
CALIFORNIA, ADJUSTING THE CAMPAIGN CONTRIBUTION LIMIT OF \$1,140 AS  
SET FORTH IN GMC SECTION 1.10.030(B) TO \$1,190 CONSISTENT WITH THE  
CONSUMER PRICE INDEX**

**WHEREAS**, On October 18, 2016, the City Council adopted Ordinance No. 5889, which amended Glendale Municipal Code, 1995 ("GMC") Section 1.10.030(B) to increase the campaign contribution limit of \$1,000 to a \$1,100; and

**WHEREAS**, On February 5, 2019, the City Council adopted Ordinance No. 5921 which, among other things, amended GMC Section 1.10.030(F) enabling the City Council to review the contribution limits in July of each odd numbered year, commencing July 1, 2019, and make Consumer Price Index adjustments to the contribution limits rounded up to the nearest ten dollars; and

**WHEREAS**, on July 9, 2019, the City Council adopted Resolution 19-80, thereby adjusting the individual contribution limit, per CPI, from \$1,100 to \$1,140; and

**WHEREAS**, the City Council has considered staff's presentation of the Consumer Price Index adjustment and increase of 4.33% based on the month ending April 2021 and deems it appropriate to increase the current campaign contribution limit of \$1,140 set forth in GMC Section 1.10.30(F), by \$50 (which is \$49.36 rounded up to the nearest ten dollars).

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF  
GLENDALE, CALIFORNIA:**

Pursuant to Glendale Municipal Code, 1995 (GMC), Section 1.10.030(F), and based on the Consumer Price Index (CPI – All Urban Consumers) Los Angeles, Long Beach, Anaheim, with the month ending April 2021, the City Council hereby increases the current campaign contribution limit of GMC 1.10.030(B) to \$1,190.
