**A RESOLUTION OF THE COUNCIL OF THE CITY OF GLENDALE, CALIFORNIA, TO DISPENSE WITH THE BIDDING PROCEDURES SET FORTH IN GLENDALE MUNICIPAL CODE SECTION 4.12.010(A)(1) AND AUTHORIZING THE DEPUTY DIRECTOR OF FINANCE-PURCHASING, OR HIS DESIGNEE, TO SOLICIT COMPETITIVE BIDS AND EXECUTE A CONTRACT PURSUANT TO GLENDALE MUNICIPAL CODE SECTION 4.12.010(A)(3) FOR THE SLOW STREETS PROGRAM – INSTALLATIONS AND MAINTENANCE**

**WHEREAS**, at their April 6, 2021 meeting, the Council provided direction for implementation of a permanent Slow Streets Program; and

**WHEREAS**, to effectuate that direction, the Public Works Department proposes replacement of 300 existing temporary Slow Street Program signs with permanent sign assemblies; and

**WHEREAS**, the codified, formal bidding process for public works in GMC Section 4.12.010(A)(1) would take approximately 3 to 4 months; and

**WHEREAS**, the Glendale City Charter, Article VI, Section 9 provides an exemption to the bidding procedures set forth in GMC Section 4.12.010(A)(1) where the Council determines it is in the best interest of the City; and

**WHEREAS**, the temporary Slow Streets Program signage has deteriorated and needs to be urgently replaced with permanent solutions; and

**WHEREAS**, due to the non-technical nature of this project and the shorter bidding process desired, the Public Works Department requests Council's authorization to dispense with the bidding procedures set forth in GMC Section 4.12.010(A)(1) and authorize the Deputy Director of Finance-Purchasing, or his designee, to solicit bids and execute a contract pursuant to GMC Section 4.12.010(A)(3) for the Slow Streets Program – Installations and Maintenance.

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF**

**GLENDALE:**

1. That the foregoing facts are deemed to be true and correct and a basis for dispensing with the bidding procedures set forth in GMC Section 4.12.010(A)(1) and authorizing the Deputy Director of Finance-Purchasing, or his designee, to solicit bids and execute a contract pursuant to GMC Section 4.12.010(A)(3) for the Slow Streets Program – Installations and Maintenance.

2. That the Council finds it is in the best interest of the City to dispense with the bidding procedures set forth in GMC Section 4.12.010(A)(1) and authorize the Deputy Director of Finance-Purchasing, or his designee, to solicit bids and execute a contract pursuant to GMC Section 4.12.010(A)(3) for the Slow Streets Program – Installations and Maintenance, as set forth in the Report to Council dated September 14, 2021.
