Commissioner Comments:

- Are units 1-5 currently in use?
- When the units are removed, where will Glendale get power?
- During conversion, are units operational?
- What is the status for getting community solar? Any specific areas in mind?
- Is Glendale providing a net meter aggregation program?
- Fee and tariff program? What is prohibiting Glendale from utilizing this program?
- What are the geo-thermal sources?
- Peak savings program- How many people have signed up?
- Relying on our neighbors: Do we have connections with Edison? Are we looking into this?
- Impact of wildfires cause by infrastructure

- How much progress, in megawatts, has Glendale made locally to address energy needs?
- Glendale should explore other options for power, such as solar.
- Will the EIR address top energy users? Targeting certain users in order to reduce peak energy usage: provide an incentive for top users to participate in a voluntary program to reduce energy usage
- Streetlight program: Transitioning to full LED in the City of Glendale. Would like to see a commitment from GWP to be fully LED by a certain date.

b. Glendale Water and Power–Water

Michael De Ghetto, Chief Assistant General Manager of Water, sharing a PowerPoint presentation regarding sustainability measures within their department:

- Types of Use: most water usage is residential.
- Codes and Enforcement
- GWP Water Conservation Programs (available for businesses and residents)
- Early Adopter of Sustainable Practices
- Pioneers in Recycling
- Recycled System
- Water Energy Nexus

Commissioner Comments:

- Types of use chart: Does the single-family water usage offset multifamily home water usage? Maybe use another graph to more accurately represent the curve.
- Why is water usage measured and represented in HCF (hundred cubic feet) rather than gallons?.
- Is the jump in summer usage credited to outdoor watering, such as lawns?
- Is there a percentage of updated turf lawns in Glendale?
- How are rebate amounts set?
- If a resident is renovating their yard, renovations require permits. Is Glendale Water working with any retailers that sell gardening products or landscape architects to help spread the word about the program?
- With a shared meter, there is no incentive for residents to repair a leak. Maybe the City can incentivize residents.
- Have you found an ideal ordinance for retrofitting?
- How many people have enrolled for peak savings program?

- Smart Home Update Program: 1/3 of residential are single family. It is important to highlight that the single family units use the same amount of water as the rest of the 2/3 (multifamily units).
- City should explore new strategies of sharing programs, like the Smart Home Upgrade Program, in order to make it more accessible for residents.
- What are your projections of reclaimed water use? Are these percentages increasing?
- What percentage of our water comes from ground water?
- Does most of the water coming out of the water reclamation plant go into the LA River?

- When do you project the finalization of the RFP?
- Will the RFP be shared with the Sustainability Commission?
- In one slide, short- and long-term goals were identified. Would like to see a shorter term of strategies and objectives, such as goals that can be met in 1-3 years. 2030 seems too far away. Focus on short term, high-impact strategies.

d. Sustainable Purchasing Program–Update

David Jones providing an update on the Sustainable Purchasing Program

Commissioner Comments:

- The word "Specification" is used frequently. Clarifying term on page 3 in the report: "Specify government or third-party verified green specifications", by that do you mean that Glendale will require that the EPD's products are third-party verified? Change terminology to say "EPD's be third-party verifiable or certifiable."
- "Extended producer responsibilities" insert a verb there to say something such as "include extended producer responsibilities"
- "C. Review contracts to see what is coming up..". Research should be done before the contract goes out in order to implement ideas more efficiently. It will be too late to scope sustainability opportunities
- combine "office supply vendors- specify default green option" with "develop a core green market basket"
- "Researching an efficient method to track the spending of sustainable and environmental green purchasing" suggesting the division of purchasing categories such as durable goods, consumables, construction and remodels, and services.
- indoor air quality is 2-5 times worse than outside air quality which could be credited to cleaning products, new furniture, etc. Add a bullet point to include products that are low emitting and low VOC to improve indoor air quality.
- List of Green Programs under the Year One Goals bullet point 5, add BIFMA to the list. BIFMA focuses on environmentally preferable office furniture.
- SEAQMD 11-13 and 11-68 goals should be included
- 3-5 years to implement is too long
- EPP/ EPR ordinance was not mentioned.
- Default to what the EPACPG recommends as recycled content, they have 16 other categories
- Is paper one of the largest buys?
- Is motor oil one of the largest buys? As Glendale converts to an electric fleet, motor oil will be phased out.
- US EPA: Utilize the levels for post consumer recycled content
- Ignore lifecycle assessments (LCA)
- Put the EPP report work on the vendor rather than completing it yourself.
- Narrow the items you let staff use, choose the specific items that are refillable and do not use plastic.

- 5.4 on page 7. Comparing printer paper, recycled paper is more expensive. What will staff do in this situation, purchase costeffective products or environmentally friendly products?
- Price should not be a factor. Go with the national standard, 30% recycled materials.

e. Reach Code- Information Report

Amy Rider from the Building Decarb Coalition sharing a presentation

- Building Electrification: new construction only
- 4 appliances: water heating, space heating, clothes drying, and cooktops
- Electrification improves affordability
- Indoor air pollution from burning gas indoors, specifically in homes.
- Indoor air pollution contributes to outdoor air pollution
- State Energy Code and Local Reach Code
- Reach code adoption process
- New Construction Approaches
- 48 local governments have taken action

Commissioner Comments:

- Utility rates are higher in gas powered buildings
- People should have the ability to choose whether or not they use gas
- Please clarify the state energy code moving to all electric by 2023.
- Reach code would apply for new development
- This is a very small means of easing the City of Glendale's dependence on fossil fuels.
