**A RESOLUTION OF THE COUNCIL OF THE CITY OF GLENDALE
DISPENSING WITH COMPETITIVE BIDDING AND
AUTHORIZING THE DEPUTY DIRECTOR OF
FINANCE/PURCHASING (PURCHASING ADMINISTRATOR) TO
EXECUTE A PURCHASE ORDER CONTRACT FOR THE
PROCUREMENT OF TWO USED 2008 AUTOCAR XPEDITOR
HEIL RAPID RAIL CNG SIDE LOADING REFUSE TRUCKS**

WHEREAS, on December 1, 2021, the City of Glendale will change to a commercial franchise waste hauling system, leaving municipal waste management operations to solely service residential customers — single-family and multi-family of fewer than five units; and

WHEREAS, a route optimization analysis determined that the city needs to increase the amount of residential waste hauling routes in order to include required breaks, fueling and dumps and to avoid overtime, staff fatigue and missed service; and

WHEREAS, additional side-loading refuse trucks are needed to implement these increased routes until new trucks are manufactured and delivered; and

WHEREAS, staff analyzed several alternatives and determined the purchase of two refurbished 2008 Autocar Xpeditor Heil Rapid Rail CNG refuse trucks from King Motors to be the best option currently available; and

WHEREAS, staff determined that the purchase price of \$35,000 each plus sales tax for two refurbished 2008 Autocar Xpeditor Heil Rapid Rail CNG refuse trucks to be fair and commensurate for the value of this equipment; and

WHEREAS, Glendale Charter Art. VI Section 9 provides an exception to competitive bidding where City Council determines that it is in the best interest of the City to dispense with competitive bidding.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GLENDALE:

1. The foregoing facts are deemed to be true and correct, and are a basis for dispensing with competitive bidding and authorizing the execution of a purchase order contract with King Motors.
2. The City Council hereby dispenses with competitive bidding and authorizes the Deputy Director of Finance/Purchasing (Purchasing Administrator) to execute a purchase order contract with King Motors for or the purchase of two (2) used 2008 Autocar Xpeditor Heil Rapid Rail CNG Side Loading Refuse Trucks for \$77,175. The purchase order contract shall be in a form approved by the City Attorney.
3. Authorizes a 5% reserve for contingency, equal to \$3,859.
