**RESOLUTION OF THE COUNCIL OF THE CITY OF GLENDALE, CALIFORNIA
AUTHORIZING THE CITY MANAGER OR A DESIGNEE TO EXECUTE ALL
NECESSARY DOCUMENTS ASSOCIATED WITH 2020 URBAN AREA SECURITY
INITIATIVES GRANT PROGRAM**

WHEREAS, the City of Glendale has been successful in obtaining \$53,475 in grant funds under the 2020 Urban Area Security Initiatives (UASI) Grant Program;

WHEREAS, these grant funds are allocated between City of Los Angeles and those cities recognized by the County of Los Angeles Operational Area which includes the City of Glendale;

WHEREAS, the grant funding is administered by the City of Los Angeles and provided to the City of Glendale under a Subaward Agreement ("Agreement") between the City of Los Angeles and the City of Glendale;

WHEREAS, the projects associated with the FY20 UASI grant program are for the purpose of continuing efforts to enhance public safety efforts within Glendale and the region;

WHEREAS, in May 2021, the City received \$216,525 for the Oat Capacity Maintenance project and the additional grant funding (\$53,475) brings the total project funding to \$270,000;

WHEREAS, the funding will be allocated to upgrade the capacity at Glendale's interoperable communications radio repeater site located at Oat Mountain, as more specifically discussed in the report to the City Council, dated November 16, 2021, by the Chief Information Officer;

WHEREAS, the projects associated with the FY20 UASI grant program have been approved by the State of California Office of Emergency Services Homeland Security authorizing branch;

WHEREAS, any liability arising out of the performance of the Agreement related to this grant shall be the responsibility of the City of Glendale;

WHEREAS, grant funds provided shall not be used to supplant expenditures controlled by the City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLENDALE, CALIFORNIA AS FOLLOWS:

The City Council hereby:

SECTION 1. Finds the above recitals to be true and correct.

SECTION 2. Approves participation in the United States Department of Homeland Security 2020 UASI Grant Program and accepts the grant funds under this program in the amount of \$53,475.

SECTION 2. Authorizes the City Manager to execute all necessary agreements, certifications, and documents to accept and implement the 2020 United States Department of Homeland Security 2020 UASI Grant Program.
