**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GLENDALE,
CALIFORNIA, AUTHORIZING THE EXECUTION OF THE
CERTIFICATIONS AND ASSURANCES AND AUTHORIZED AGENT FORMS
FOR THE LOW CARBON TRANSIT OPERATIONS PROGRAM (LCTOP)
FOR THE FOLLOWING PROJECT(S):
ELECTRIC BUS CHARGING INFRASTRUCTURE - \$138,788**

WHEREAS, the City of Glendale is an eligible project sponsor and may receive state funding from the Low Carbon Transit Operations Program (LCTOP) for transit projects; and

WHEREAS, the statutes related to state-funded transit projects require a local or regional implementing agency to abide by various regulations; and

WHEREAS, Senate Bill 862 (2014) named the Department of Transportation (Department) as the administrative agency for the LCTOP; and

WHEREAS, the Department has developed guidelines for the purpose of administering and distributing LCTOP funds to eligible project sponsors (local agencies); and

WHEREAS, the City of Glendale wishes to delegate authorization to execute these documents and any amendments thereto to Roubik Golanian, City Manager or a designee,

WHEREAS, the City of Glendale wishes to implement the following LCTOP project listed above,

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLENDALE, CALIFORNIA:

- 1) That the fund recipient agrees to comply with all conditions and requirements set forth in the Certification and Assurances and the Authorized Agent documents and applicable statutes, regulations and guidelines for all LCTOP funded transit projects.
- 2) That Roubik Golanian, City Manager or a designee be authorized to execute all required documents of the LCTOP program and any Amendments thereto with the California Department of Transportation.

- 3) That the City Manager, or a designee is authorized to proceed with the submittal of the following project nomination and allocation request to the Department in FY2021-2022 LCTOP funds:
