**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GLENDALE  
CALIFORNIA, RECITING THE FACT OF THE STATEWIDE GENERAL  
ELECTION HELD ON TUESDAY, JUNE 7, 2022, DECLARING THE RESULT  
AND SUCH OTHER MATTERS AS PROVIDED BY LAW**

**WHEREAS**, a General Municipal Election was held and conducted in the City of Glendale, California, on Tuesday, June 7, 2022, in consolidation with the California Presidential Primary Election, as required by law; and administered by the Los Angeles County Registrar-Recorder/County Clerk, and

**WHEREAS**, notice of the election was given in time, form and manner as provided by law; that Vote Centers were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by provisions of the Elections Code of the State of California for the holding of elections in Charter cities;

**WHEREAS**, on March 21, 2022, the Glendale Community College District adopted a resolution to remove Board of Trustees from the Statewide Direct Primary Election and seat the three unopposed incumbent trustees as Members of the Board of Trustees for Trustee Areas 2, 3, and 4 a copy of which is attached and made a part hereof as "Exhibit 1;" and

**WHEREAS**, the County of Los Angeles Registrar-Recorder/County Clerk canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit 2."

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GLENDALE,  
CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:**

**SECTION 1.** That the whole number of votes cast in the City, the Glendale Unified School District, and the Glendale Community College District are attached and made a part hereof as "Exhibit 3."

**SECTION 5.** That the City Clerk shall immediately make and deliver to each persons so elected, a Certification of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.
