BOARD OF TRUSTEES FROM THE STATEWIDE DIRECT PRIMARY  
ELECTION AND SEATING OF UNOPPOSED INCUMBENT TRUSTEES

WHEREAS, the members of the Glendale Community College District Board of Trustees whose terms of office expire in 2022 have qualified for the ballot, and

WHEREAS, the number of candidates for the governing board does not exceed the number required to be elected,

BE IT, THEREFORE, RESOLVED AND ORDERED, that in accordance with Education Code Section 5326, the Los Angeles County Registrar-Recorder remove the Glendale Community College District Board of Trustees from the Statewide Direct Primary Election to be held on Tuesday, June 7, 2022.

BE IT FURTHER RESOLVED, that in accordance with Education Code Section 5328 the qualified incumbent candidates, Dr. Armine G. Hacopian (Area 3), Yvette Vartanian Davis (Area 4) and Ann H. Ransford (Area 2) are to be seated for a four-year term effective with the first meeting of the Board of Trustees scheduled after the election date of June 7, 2022.

### DESCRIPTION OF HISTORY / BACKGROUND

Education Code section 5326 states that if at the close of nominations for the Board of Trustees election, the number of nominees does not exceed the number of offices available, the persons nominated shall be seated as the trustees.

At the close of nominations for the June 7, 2022 Statewide Direct Primary Election, the number of nominees for the Glendale Community College District Board of Trustees for Areas 2, 3 and 4 did not exceed the number of offices available. The nominees are the incumbent trustees, Dr. Armine G. Hacopian (Area 3), Yvette Vartanian Davis (Area 4) and Ann H. Ransford (Area 2).

By the Board adopting this resolution, the District can have the Los Angeles County Registrar-Recorder/County Clerk remove the Glendale Community College District Board of Trustees election from the Statewide Direct Primary Election. This will save the college an estimated \$220,000 of election costs. The resolution also recognizes that by Education Code Section 5328 the three unopposed incumbent trustees nominated will be seated at the organizational meeting of the Board scheduled under Board Policy 2305, for the first meeting of the Board of Trustees following the June 7, 2022 Statewide Direct Primary Election.

Estimated savings to the District of \$220,000 in election costs.

## RECOMMENDATION

The Superintendent/President recommends that the Board of Trustees adopt Resolution No. 24-2021-2022, notifying the Los Angeles County Registrar-Recorder/County Clerk to remove the Glendale Community College District Board of Trustees from the June 7, 2022 Statewide Direct Primary Election, and to seat at the organizational meeting of the Board on June 21, 2022, Dr. Armine G. Hacopian (Area 3), Yvette Vartanian Davis (Area 4) and Ann H. Ransford (Area 2) to a four-year term effective on the date of the first meeting of the Board of Trustees following the June 7, 2022 Statewide Direct Primary Election.
