**RESOLUTION OF THE COUNCIL OF THE CITY OF GLENDALE, CALIFORNIA
AUTHORIZING THE CITY MANAGER OR A DESIGNEE TO EXECUTE ALL
NECESSARY DOCUMENTS ASSOCIATED WITH THE 2021 URBAN AREA
SECURITY INITIATIVES GRANT PROGRAM**

WHEREAS, the City of Glendale has been successful in obtaining \$1,454,709 in grant funds under the 2021 Urban Area Security Initiatives (UASI) Grant Program for use by the Glendale Fire and Police Departments;

WHEREAS, these grant funds are allocated between City of Los Angeles and those cities recognized by the County of Los Angeles Operational Area which includes the City of Glendale;

WHEREAS, the grant funding is administered by the City of Los Angeles and provided to the City of Glendale under a Subaward Agreement ("Agreement") between the City of Los Angeles and the City of Glendale;

WHEREAS, the projects associated with the FY21 UASI grant program are for the purpose of continuing efforts to enhance public safety efforts within Glendale and the region;

WHEREAS, the projects associated with the FY21 UASI grant program are part of the Los Angeles Operational Area's regional funding priorities and have been vetted through Los Angeles area fire and police regional coordination agencies, as well as the City of Los Angeles Office of Homeland Security and Public Safety;

WHEREAS, the projects associated with the FY21 UASI grant program have been approved by the State of California Office of Emergency Services Homeland Security authorizing branch;

WHEREAS, the projects associated with the FY21 UASI grant program are set forth in the Report to the City Council dated August 9, 2022, and have been approved by the State of California Office of Emergency Services Homeland Security authorizing branch;

WHEREAS, any liability arising out of the performance of the Agreement related to this grant shall be the responsibility of the City of Glendale; and

WHEREAS, the grant funds provided under the FY21 UASI grant program shall not be used to supplant expenditures controlled by the City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLENDALE, CALIFORNIA AS FOLLOWS:

The City Council hereby:

SECTION 1. Finds the above recitals to be true and correct.

SECTION 2. Approves participation in the United States Department of Homeland Security 2021 UASI Grant Program and accepts the grant funds under this program in the amount of \$1,454,709.

SECTION 2. Authorizes the City Manager, or a designee, to execute all necessary agreements, certifications, and documents to accept and implement the United States Department of Homeland Security 2021 UASI Grant Program.
