**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GLENDALE, CALIFORNIA
TO DISPENSE WITH COMPETITIVE BIDDING AND AUTHORIZE THE CITY
MANAGER OR A DESIGNEE TO EXECUTE AN AMENDMENT TO THE AGREEMENT
BETWEEN THE CITY AND AXON ENTERPRISE, INC. FOR THE PURCHASE OF
CAMERA EQUIPMENT, RELATED SOFTWARE, MAINTENANCE AND STORAGE,
PARTS, AND SERVICES**

WHEREAS, in April 2019, the City Council approved a resolution to dispense with competitive bidding and enter into a contract with Axon Enterprise, Inc. ("Axon") for 5 years to provide in-car video cameras and related hardware and software to include Evidence.com;

WHEREAS, the City Council's approval also gave the Police Department the option to purchase body worn cameras with a total amount not to exceed \$1,700,000;

WHEREAS, in October 2019, Amendment No. 1 to the contract with Axon was executed to procure additional hardware to support the in-car video systems;

WHEREAS, in December 2020, Amendment No. 2 was executed for the early adoption of Axon's body worn cameras;

WHEREAS, in December 2020, the City Council authorized Amendment No. 3 to the contract to provide hardware and software related to the unmanned aerial system program; approval was also given for a new maximum cost not to exceed \$1,750,000;

WHEREAS, in June 2021, Amendment No. 4 to the City's contract with Axon was executed to update the equipment list with cameras more suitable for motor officers;

WHEREAS, on November 29, 2022, the Police Department presented a report to the City Council requesting authorization to purchase sixteen (16) additional in-car-video camera sets, nine (9) interview room cameras, and the migration of photo / video evidence from the Police Department's legacy system to Axon's Evidence.com platform;

WHEREAS, as of late 2019, all new digital evidence is housed in Axon's Evidence.com platform and thus migration of data in the Police Department's legacy system to Evidence.com is needed for efficiency and to allow for digital sharing with the Los Angeles District Attorney's office as well as other law enforcement partners as appropriate;

WHEREAS, the camera systems in the Police Department's interview rooms must be replaced because they are no longer supported by the vendor;

WHEREAS, in an effort to have all front-line enforcement vehicles outfitted with the new in-car-video cameras, the Police Department requires new systems for unmarked enforcement vehicles;

WHEREAS, purchasing the additional cameras and migration of digital data to Axon's Evidence.com will maintain compatibility of systems currently used by the Police Department; and

WHEREAS, Glendale City Charter, Article VI, Section 9 provides an exemption to competitive bidding when the Council determines it is in the best interest of the City to dispense with competitive bidding.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLENDALE, CALIFORNIA THAT:

1. The foregoing facts are deemed to be a true and correct and a basis for dispensing with competitive bidding;
2. The City Council hereby dispenses with competitive bidding and authorizes the City Manager, or a designee, to execute an amendment to the contract between the City and Axon Enterprise, Inc. for the purchase of camera equipment, related software, maintenance and storage, parts, and professional services for the life of the equipment, adding \$230,000 to the contract for a new not to exceed amount of \$1,980,000, as more specifically discussed in the report to the City Council dated November 29, 2022.
3. The foregoing facts are deemed to be true and correct and a basis for dispensing with competitive bidding and the Council hereby finds that it is in the best interests of the City to dispense with competitive bidding.
