5. CITY COUNCIL/STAFF COMMENTS

Councilmember Najarian thanked everyone who attended his father's funeral and appreciated the outpouring of compassion by the city.

Councilmembers Kassakhian and Asatryan attended SCAG (Southern California Association of Governments). Kassakhian stated that several interesting topics were discussed during the SCAG meeting including electrifying transportation and how different cities and agencies deal with the housing crisis.

Police Chief Cid provided a brief update on a significant arrest regarding a suspected fentanyl dealer for the death of Tevan Gevorkyan, a 19-year-old teen, in 2021. Kassakhian

and Asatryan thanked the Police Department for their efforts. Asatryan recognized the Police Department for their community outreach, partnership, and engagement. She also recognized the lack of updated educational curricula from the state on drug usage and overdose that families can access.

Fire Chief Ernst provided a brief report on the rescue mission of six individuals after roof beams or trusses had collapsed at a construction site. Councilmembers thanked the Fire Department for a job well done. Najarian asked that the construction site be investigated. City Manager Golanian stated that the newly hired Building Official, Ara Sargsyan, and other city building inspectors and engineers were there to evaluate and "red tag" the site. Director of Community Development Bradley Calvert stated that once the site was deemed safe to re-enter, the site was "yellow tagged" so that clean-up efforts can proceed. Calvert explained that the construction will not be allowed to continue until safety and standard code protocols are met.

Director of Community Development Bradley Calvert announced that the city will launch its first Small Business Summit from May16-18. More information can be found at www.chooseglendale.com. Asatryan stated that the different sessions at the Small Business Summit will be available in different languages and translation devices will be available for those who have language barriers. She added that the Glendale Small Business Summit was organized to coincide with National Small Business Week.
