EXECUTIVE SUMMARY

Periodically, City departments present resolutions to Council that provide for records destruction. This request covers documents generated through the normal business operations of the Fire Department. Government Code Section 34090 provides that (subject to certain exceptions) with the approval of the legislative body by resolution and the written consent of the city attorney, the head of a city department may destroy any city record, document, instrument, book or paper, under his charge, without making a copy thereof, after the same is no longer required, provided it is at least two years old.

RECOMMENDATION

It is requested that the City Council approve the attached resolution approving the destruction of certain city records of the Fire Department.

BACKGROUND

The Fire Department has identified the listed documents to be destroyed by Safe Shred. As of 2015, the fire department converted to a digital records system which eliminated the need for paper records.

The following records meet city retention policy requirements and are proposed to be destroyed:

- Collection Reports and Billing 2002-2010
- Subpoenas 2012-2019
- EMS Staff Meeting Minutes 2008-2013
- Copies of Checks 2014-2018
- Invoice Copies and Receipts 2006-2014
- Billing Records- 2018
- Zoll Logs- 2010-2018
- Narc Logs 2010-2018
- EMS Surveys 2004-2012
- EMS Continuing Education Records 2008-2014
- Command Staff Meeting Minutes 2019
