A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GLENDALE, CALIFORNIA, DISPENSING WITH COMPETITIVE BIDDING TO APPROVE AN AGREEMENT WITH ECLEAN TECHNOLOGIES, LLC FOR THE RENTAL OF AQUEOUS ZONE EQUIPMENT FOR SANITIZATION OF RESTROOMS AT PARKS AND PARK FACILITIES AND TO AUTHORIZE THE CITY MANAGER OR A DESIGNEE TO EXECUTE AN AGREEMENT IN A TOTAL AMOUNT NOT TO EXCEED \$304,000 FOR A 3-YEAR TERM

WHEREAS, it is part of the Community Services & Parks (CSP) Department's mission to enhance the quality of life by providing safe and well-maintained parks and public spaces;

WHEREAS, eClean Technologies, LLC is the exclusive distributor for stand alone, wall mount point of use instant sanitization units that can be connected to standard plumbing, without compromising water pressure and flow and provide aqueous ozone sanitization;

WHEREAS, the aqueous zone products are compliant with the Environmental Protection Agency and are designed to prevent and destroy viruses including but not limited to E. Coli, Salmonella, Aspergillus, bacteria, and other harmful pathogens;

WHEREAS, in September 2022, a preliminary analysis of the equipment was performed in a pilot study, and staff reported that the use of the system at Glendale Sports Complex and Brand Park successfully deodorized and neutralized any elements that causing a foul smell;

WHEREAS, the wall mounted sanitization unit is simple and effective as it does not require other components, saving staff time for routine sanitizations and reducing the need to use chemicals such as bleach or other harmful disinfectants, thereby improving operational efficiency at all parks and parks facilities;

WHEREAS, operational efficiency is a priority of the City Council to find sustainable methods to run City operations, and implementing aqueous ozone technology for park restroom maintenance will reduce unnecessary cleaning costs and produce efficient results;

WHEREAS, the City of Glendale Charter, Article VI, Section 9, provides an exemption to competitive bidding where the Council determines it is in the best interest of the City to dispense with competitive bidding; and

WHEREAS, providing safe and well-maintained parks and public facilities is necessary, it appears that adequate justification exists and it is in the City of Glendale's best interest, upon the recommendation of the Director of Community Services & Parks, to dispense with competitive bidding and authorize the City Manager or a designee to

execute an agreement with eClean Technologies, LLC for the procurement of aqueous zone equipment for the sanitization of restrooms at parks and park facilities.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLENDALE, CALIFORNIA:

- The foregoing facts are deemed to be true and correct and are a basis for dispensing with competitive bidding and the Council hereby finds that it is in the best interests of the City to dispense with competitive bidding; authorizing the City Manager or a designee to execute an agreement with eClean Technologies, LLC for the procurement of aqueous ozone technology for the sanitization of restrooms at parks and park facilities.
- 2. The City Council hereby dispenses with competitive bidding and authorizes the City Manager or a designee to execute an agreement with eClean Technologies, LLC for rental, delivery, and training for thirty-one (31) wall mount aqueous ozone equipment for the sanitization of restrooms and two (2) mobile pressure washers to sanitize other amenities at parks and park facilities throughout the City of Glendale for a total not-to-exceed amount of \$304,200 for a 3-year term, with the option to buy at the end of the term, subject to approval by the City Attorney.
