## 5. CITY COUNCIL/STAFF COMMENTS

Councilmember Kassakhian provided his comments regarding the attack of Hamas on Israel and wished for peace. He stated that Armenian-Americans are feeling a lot of trauma and déjà vu from seeing the same images of violence that happened in Artsakh. Kassakhian stated that he prays for peace for the people of Israel and Palestine. Kassakhian attended the Lithuanian Days Festival at St. Casimir Church Los Angeles and Octoberfest in Montrose. He also attended the Armenian Bone Marrow Walkathon and encouraged the public to support the organization by signing up for their bone marrow registry. Kassakhian invited the public to watch a documentary called "Cup of Salvation," at the Glendale Laemmle Theater. He asked staff to agendize a discussion to consider supporting US Congresswoman Judy Chu's and US Senator Alex Padilla's call to urge the Biden-Harris Administration to expand the boundary of California's San Gabriel Mountains National Monument.

Councilmember Asatryan announced that October is also "Domestic Violence Awareness" Month. For anyone that needs assistance on domestic violence, YWCA Glendale provides legal assistance, adult and children counseling, housing navigation support, trauma support, childcare, emergency shelter, crisis assistance, financial assistance, and food pantry services. The public can reach YWCA Glendale at (818)242-4155 and the crisis hotline at (888)999-7511. Asatryan had an opportunity to go on a police car ride-along and asked staff to provide a memo on how the city is integrating and coordinating services for the unhoused population. She congratulated the Montrose Chamber of Commerce for a successful Octoberfest and the Glendale Chamber of Commerce for hosting the Jewel City Gala. Asatryan joins Kassakhian in his statement about what is happening in Israel and Palestine. As a response and a correction to a comment made earlier by a member of the public, she stated that there is no more blockade in Artsakh, the Armenian population was forced to deportation. Asatryan asked to agendize for discussion a better structure for the city's friendship and sister cities and to provide an update regarding the work that is being done. She also asked to agendize for discussion recycling requirements for new construction multi-family units. Asatryan asked for an updated report on the Organics Waste and Recycling Program, which was discussed during the Council in Your Neighborhood Meeting on October 3 at Sparr Heights.

Councilmember Najarian announced that the LA Metro Board will increase the northbound and southbound trains that serve the Glendale station which will not only make traffic on freeways better but also improve the air quality. He stated that he authored a second motion to make those trains silent and not sound their horns from Atwater to Northwest Glendale.

Councilmember Devine stated that every week we hear about the Armenian Genocide and express our sadness for that community. She added that it seems that another genocide is happening in Israel. Devine expressed that her heart and prayers are with her Jewish friends and community and she wishes that those who have been captured will be rescued and safe.

Mayor Brotman provided his comments regarding what has been taking place in Israel and Gaza. He called the purposeful targeting of civilians as horrific acts of terrorism. He expressed his sympathy to all the families who have lost loved ones or have loved ones who are held captive. He also stated that he hopes that Israel doesn't act out of vengeance and commit the same offenses as targeting civilians in Gaza but be as measured as possible. He also stated that City Hall will be lit up with white and blue lights of the Israeli flag in support. Mayor Brotman stated that Adams Hill held an arts festival but he was unable to attend. He was able to attend October Fest which was a packed event.

City Manager Roubik Golanian had the opportunity to attend the celebration of a 30 year veteran of the Beeline service. He invited Khachig Petrosian to the podium. He stated that Khachig has been an integral part of the Beeline service and his commitment to excellence, professionalism and exceptional customer service has set a high standard for the rest of his team to follow. Khachig was presented with a commendation from the mayor. Councilmember Kassakhian also made congratulatory remarks.

City Clerk Dr. Suzie Abajian invited the public to attend the Candlelight Vigil & Purple Tie Awards on Wednesday, October 11, at Glendale City Hall. The event is to honor men working to end domestic violence and build a culture of support for survivors in Glendale. It is cosponsored by YWCA of Glendale and Pasadena and the Glendale Commission on the Status of Women. She also made remarks about Indigenous Peoples' Day.
