## **RECOMMENDATION**

---

It is requested that the City Council approve the attached resolution providing grant funds for curbside collection of used oil and oil filters.

## **BACKGROUND/ANALYSIS**

---

Since 1992, the Glendale Fire Department's Environmental Management Center (EMC) has been successful in securing this grant in order to provide curbside collection of used oil and oil filters from Glendale residents. The program collects and recycles more than 8,000 gallons of used motor oil annually. The recommended action will authorize the Glendale Fire Department to submit an application to the California Department of Resources Recycling and Recovery (CalRecycle) for the 2020/2021 Used Oil Payment Program (OPP). This grant is awarded to local government agencies for programs that provide used oil collection opportunities. The funding from this grant partially offsets the salary and benefits of the position assigned to the Used Oil Recycling Program, as well as other program-related costs (i.e., programming, materials, training). The objective is to continue our effective curbside collection program that provides Glendale residents an environmentally appropriate disposal option for used motor oil. This program is in addition to our Household Hazardous Waste collection days at the EMC. The Thursday curbside collection program is available by appointment to Glendale residents only. The principle goal of this program is to divert hazardous waste from being disposed of at the City's Scholl Canyon Landfill and to reduce incidents of illegal disposal, and injury to the public and the environment.

## **FISCAL IMPACT**

---

This grant program will award the City approximately \$50,000. The funding will be used to partially offset costs associated with the full-time position dedicated to this program, as well as other program-related costs. The awarded funds will be deposited into the Hazardous Disposal Fund, Fire Department, State Grants revenue account (32610-2190-GFD-0000). There is no local match required.
