Jeremy has been a student in three of my geography classes over the last academic year. To Whom It May Concern,

It is with my full support that I recommend Lilia Hacoupan to join the Sustainability Commission as a student member for the City of Glendale. I've known Lilia since the Fall of 2021, when she enrolled in my Advanced Placement Environmental Science class. In my class, Lilia gained experience learning to use GIS for environmental science. She participated in assignments pertaining to the focus of the Sustainability Commission such as analyzing solar potential of residential areas, using a mobile app to collect and analyze environmental data, making maps to visualize global hunger, analyzing the effects of sea level rise in the USA, analyzing spatial data to find the best locations for a new wind farm, mapping invasive plants locally, analyzing and mapping soil textures, stream flow in relation to ocean pollution, and using remote sensing to show change over time in both urban and natural areas.

Lilia was a participant in the Citizen Science project, *Crowd the Tap*. She analyzed her tap water and contributed her data to crowdsource water quality assessment. Her web application of that project was one of the best. She visualized the data as both a map and series of graphs for each variable that she tested.

Lilia's submission for the *From the Bow Seat Ocean Awareness Contest*, our final project in AP Environmental Science, was a well written, insightful poem reflecting on the state of our environment.

In a year where most students hid behind the screen during distance learning, Yuzuna stood out for her constant willingness to participate, learn and connect. Yuzuna interacts easily with her peers, and is never afraid to speak up or ask questions. In Spanish class, she was able to pick up on grammar concepts quickly. Her work habits were impeccable, and her projects were always done with thought, creativity and attention to detail.

At the end of her Freshman year, Yuzuna applied, and was accepted into, Clark's Mock Trial program. I am the team's Teacher Coach and my husband, a Superior Court Judge in Los Angeles County, volunteers as the Attorney Coach. It is in this role as the Teacher Coach that I have had the opportunity to get to know Yuzuna better, and can more accurately speak to her unique talents. From my observations and experiences with her, I believe she possesses many skills and characteristics that would make her an outstanding asset to your program.

The Mock Trial class at our school is competitive, demanding, and rigorous. Students must apply to the class, maintain at least a B in all English classes, and submit a positive teacher recommendation to be accepted into the program. There is a wait list of over fifty students. Her acceptance into the program is an accomplishment in itself, and sets her apart from other classmates of her age.

Everyone in the class auditions to receive a role on one of the competing teams, but certain roles are reserved for students with specific skills. The role of an attorney is generally assigned to advanced students who are in upper grades or have had previous experience in Mock Trial. When I, along with the student leaders, watched and listened to Yuzuna's audition, we unanimously agreed she had strong enough potential for an attorney role. Because of her ability to break down and analyze the facts of the case, we assigned her the role of Pretrial Attorney. This role is one of the most challenging, as it requires the student to argue directly in front of the judge and respond to spontaneous questions regarding numerous court cases and holdings. This role requires a student to work more independently, without the help of teammates. During rehearsals Yuzuna quickly showed her abilities to speak with confidence and conviction. Both my husband and I were instantly impressed with her critical thinking skills and her ability to grasp the complex legal issues the Constitutional Rights Foundation builds into these cases. My husband and I do not believe in hand-feeding the answers to the students, but we do question them and try to lead them down a path of discovery. Yuzuna was able to pick up on my husband's line of questioning and continue the process of formulating proper arguments on her own. She showed that she could take criticism well, and apply the instruction to the situation immediately.

During the actual competition, Yuzuna proved that she had the skills to perform under pressure. She was able to conduct herself with poise and professionalism.

Yuzuna is also well-liked by her peers. Recently she was elected by teammates to serve as Secretary of the Mock Trial Program for the 2022-23 school year. She willingly volunteers to help others and takes on tasks that do not always receive recognition or points. She continually demonstrates a genuine desire to be of service to others. During the months in which we were not working on the competition, Yuzuna worked together with a classmate to participate in a moot court competition through Duke. To Whom It May Concern,

It is with great enthusiasm that I recommend Yuzuna Kudo for the position of Student Commissioner of the Sustainability Commission for the City of Glendale. I've known Yuzuna since the Fall of 2021 when she enrolled in my Advanced Placement Environmental Science Class. Yuzuna has been an exceptional student. She consistently does more than required, and exceeds expectations for work quality.

In my class, Yuzuna used the Los Angeles County Solar Map Application to determine the solar potential of her home. She learned how to use ArcGIS Online to make interactive web maps and apps focused on environmental issues. She also became proficient in the use of the Survey123 mobile app to collect and analyze data. With these GIS tools, Yuzuna has created thematic maps of global undernourishment and food insecurity, mapped the effects of sea level rise, performed a site suitability analysis for a new wind farm, mapped invasive plants on our school campus and in her neighborhood, collected and analyzed soil samples at school and at the neighboring Dunsmore Park to create an interpolation map of soil type. She mapped our local watershed and performed a downstream trace to show how litter and pollutants generated on our school campus will eventually make their way to the ocean through our storm drain system. Yuzuna has used satellite imagery through remote sensing viewers to create Before/After swipe maps to illustrate the extent of clearcutting in the Amazon rainforest and the expansion of fracking in Texas. She participated in the Citizen Science project, *Crowd the Tap*, to analyze drinking water quality in the community. She extended that project and [created a web application](#) that visualizes the data as both a map and series of graphs for each variable that was tested.

In another project, Yuzuna analyzed a dataset of island biodiversity using graphs and statistical analysis in Excel. Her analysis was so thorough that she has submitted her abstract for publication. Yuzuna will have a Library of Congress publication to her name come this Fall.

Yuzuna was the only student who accepted the challenge to enter the Clean Tech Competition. For this competition, she [created a survey](#) to document pet waste that was not properly disposed of, in relation to the presence or absence of pet waste stations and trash cans. She will use the data she collects to advocate for pet waste stations and/or trash cans in areas of high need identified by data. In her project, Yuzuna detailed the connection between pet waste contributing to an excessive nutrient load in local waterways leading to eutrophication. We just got notification that Yuzuna's project has been selected as a semi-finalist for the competition.

Over the summer and next school year, Yuzuna will be taking two of my GIS classes back to back. She will enhance her skills and be ready to investigate local environmental sustainability issues through spatial analysis using GIS at a professional level.

Yuzuna has a proven track record of putting in the extra hours to work on projects she is passionate about. Environmental sustainability is a topic that Yuzuna cares deeply about. She has the background education, training and aptitude to make a positive impact for the City of Glendale in this area.



She was able to determine the solar potential of her home using the Los Angeles County Solar Map Application. She learned to use the Survey123 mobile app to collect and analyze data. Emily has created thematic maps of global hunger, used data from the National Oceanic Atmospheric Administration to analyze the effects of sea level rise in the USA and performed a site suitability analysis for a new wind farm. She's made a local map of invasive plants, participated in a class project collecting and analyzing soil samples at school and at the neighboring Dunsmore Park to create an interpolation map of soil type. She has used GIS to map our local watershed and perform a downstream trace to show how litter and pollutants generated on our school campus will eventually make their way to the ocean through our storm drain system.
