EXECUTIVE SUMMARY

The intent of this report is to allow the donation of outdated police equipment to the City of Arvin Police Department.

COUNCIL PRIORITIES

RECOMMENDATION

That the City Council authorize the donation of six outdated tasers (and related equipment) to the City of Arvin Police Department.

BACKGROUND

The Glendale Police Department has recently received a request from the City of Arvin Police Department for tasers that are no longer used or needed by the Department. (City of Arvin is in Kern County.)

In reviewing its inventory, the Glendale Police Department has determined that it has six tasers that are outdated and no longer needed. The Taser X26P is outdated and has been replaced by the updated Taser 7 which was completely redesigned with new features that dramatically improve its effectiveness for law enforcement purposes. The Department has transitioned away from the Taser X26P and has outfitted its personnel with the Taser 7. In addition to the tasers, the Department seeks approval to donate six Blackhawk left-handed holsters, two Blackhawk right-handed holsters, two nylon ambidextrous holsters, fifty live cartridges, and one Evidence Sync Cable.

ANALYSIS

Glendale Municipal Code section 4.68.030 provides:

The city manager is authorized to sell or exchange from time to time any and all equipment, materials, fixtures and other personal property having salvage value which is obsolete or no longer useful or surplusage to the city, or for the place of which similar property is to be purchased. The city manager may sell the same for the best price obtainable in the open market or, when deemed advisable, to the highest bidder at a public sale; or the city manager may exchange the same for other property or for credit on other property.

Although this section discusses the sale of obsolete city property, the City Council may authorize the donation of such property. If the City Council adopts the resolution to donate the tasers to the City of Arvin such donation will be "AS IS" with no warranties of any kind. The donation will also include a waiver of liability.
